APPROVAL OF 08/02/2021 MINUTES

 The meeting minutes were previously approved electronically and have been posted to the CIRPCA website.

- President's Report
 - We now have a candidate for each open Board position. The slate is:
 - President: Pete Walker
 - Vice-President: Amanda Brown
 - Secretary: Keith Morgan

 - The notification of membership and election process will proceed as defined in the bylaws.
 - The annual Winery Tour is October 16. Due to the unresponsiveness on the part of Huber Winery, Rob will revamp the tour route. Patoka Lake Winery has indicated that they would welcome CIRPCA. Rob will finalize the details in the coming week.
 - The PCA subsidy for charitable events will be used to support the Going to the Dogs Tour on September 25. All proceeds from this event benefit Speedway Animal Rescue.
- Vice President's Report
 - Pete noted that details surrounding PCNA's Sport Cars Together event at IMS,
 September 10 12, remain elusive. We will adopt a "play it by ear" approach to the event. In spite of this, it is felt that Sports Cars Together has the potential to become a big, annual event.
- Treasurer's Report
 - The IRS has levied a \$4800 late filing fee against CIRPCA>
 - Our accountant believes that he can persuade IRS to waive the fee. Our accountant has Power of Attorney and can speak for CIRPCA in this matter.
 - Chase Bank is changing our checking account type. Going forward, we need to be aware that there is a minimum balance.

- Our CD's have accrued several hundred dollars. One is maturing in November.
- Greg has created a Chart of Accounts for our various events (Page 9 of the August Treasurer's Report).
 - This approach provides improved visibility to actual revenue/expenses. This level of detail will aid in decision making.
- For our revenue generating events, we must remain mindful that, per non-profit tax regulations, the majority of revenue must come from our club members.
- Greg noted that we should consider changing our approach to DE fees and refunds for no-shows. Historically, we have given refunds to no-shows, no questions asked. With the increased costs we face, this approach puts CIRPCA at some degree of financial risk.
 We should consider changing our rate structure, policies around refunds, etc. It was agreed that these issues would be formally reviewed after Pumpkin Run.
